How will I be billed?	A line item for participation in <b>Green Power Switch</b> will appear on your monthly power bill from your local power company.									
How will my electricity bill be calculated?	<b>Green Power Switch</b> is sold to residential and commercial consumers in 150-kilowatt-hour blocks (about 12 percent of a typical consumer's monthly energy use). Each block adds \$4 to the customer's monthly power bill. Consumers may buy as many blocks as they wish.									
How much will be total electricity service cost, including utility charges?	Each block of renewable energy purchased adds \$4 to the consumer's monthly power bill.									
Will my electricity rates change over time?	TVA may alter, amend or end <b>Green Power Switch</b> at any time. Participating consumers will be notified by mail one month in advance of any rate changes.
